



Accident Waiver and Release of Liability SUP 11 City Tour

I am applying for entry into The SUP 11-City Tour (including day of entry and “prologue through Leeuwarden”). I realize that this event could not be held unless I am willing to assume all consequences of these risks. Therefore I assume full responsibility to inform myself as to all the dangers and risks and I sign this **Accident Waiver and Release of Liability** as a legally binding method of personally assuming all of these risks. In consideration of my entry I agree to execute this **Accident Waiver and Release of Liability**.

I acknowledge that The SUP 11-City Tour is an extreme test of a person’s physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to those caused by terrain, facilities, temperature, weather, condition of athletes, lack of hydration, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, escorts, spectators, event officials, event monitors, and or producers of the event. I hereby assume all of these risks of participating, and/ or volunteering, and/or escorting this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently trained for participation in the event and have not been otherwise advised by a qualified medical person.

I have read all rules and requirements for The SUP 11-City Tour and agree to comply with all rules and requirements, failure to comply would constitute negligence on my part.

I understand that at this event and other related activities, I may be photographed. I agree to allow my photo, video or film likeness to be used by the event holders, producers, sponsors, organizers and or assigns.

I acknowledge that the event holders, sponsors and organizers, in which I may participate and that it will govern my actions and responsibilities at said events, will use this **Accident Waiver and Release of Liability form**.
